CALIFORNIA EGG PRODUCTION

California's egg production during July totaled 195 million, up 11.1 million from June's production but down 60.4 million from July 2023. The all layers during the month totaled 8.57 million, up 5 percent from last month, but down 20 percent from July 2023. Eggs per 100 layers during the month were 2,278, compared to 2,246 a month earlier, and 2,383 in July 2023.

U.S. JULY EGG PRODUCTION

United States egg production totaled 9.06 billion during July 2024, down 2 percent from last year. Production included 7.76 billion table eggs, and 1.30 billion hatching eggs, of which 1.20 billion were broiler-type and 99.0 million were egg-type. The average number of layers during July 2024 totaled 370 million, down 3 percent from last year. July egg production per 100 layers was 2,451 eggs, up slightly from July 2023.

All layers in the United States on August 1, 2024 totaled 369 million, down 3 percent from last year. The 369 million layers consisted of 304 million layers producing table or market type eggs, 61.5 million layers producing broiler-type hatching eggs, and 3.76 million layers producing egg-type hatching eggs. Rate of lay per day on August 1, 2024, averaged 79.0 eggs per 100 layers, up slightly from August 1, 2023.

U.S. EGG-TYPE CHICKS HATCHED

Egg-type chicks hatched during July 2024 totaled 57.3 million, up 12 percent from July 2023. Eggs in incubators totaled 53.9 million on August 1, 2024, up 10 percent from a year ago.

Domestic placements of egg-type pullet chicks for future hatchery supply flocks by leading breeders totaled 200 thousand during July 2024, up 2 percent from July 2023.

U.S. BROILER-TYPE CHICKS HATCHED

Broiler-type chicks hatched during July 2024 totaled 863 million, up 2 percent from July 2023. Eggs in incubators totaled 746 million on August 1, 2024, up 3 percent from a year ago.

Leading breeders placed 8.32 million broiler-type pullet chicks for future domestic hatchery supply flocks during July 2024, down 2 percent from July 2023.

U.S. TURKEY HATCHERY PRODUCTION

Turkey eggs in incubators on August 1, 2024, in the United States totaled 24.8 million, down 9 percent from August 1, 2023. Eggs in incubators were up 4 percent from the July 1, 2024 total of 23.9 million eggs.

Turkey poults hatched during July 2024, in the United States totaled 20.3 million, down 10 percent from July 2023. Poults hatched were up 3 percent from the June 2024 total of 19.7 million poults.

The 20.2 million net poults placed during July 2024 in the United States were down 10 percent from the number placed during the same month a year earlier. Net placements were up 7 percent from the June 2024 total of 18.9 million.
