## KANSAS JANUARY 1 CATTLE INVENTORY

**MANHATTAN, Kan. January 31, 2022** - All cattle and calves in Kansas as of January 1, 2022 totaled 6.50 million head, down 1% from January 1, 2021, according to the USDA's National Agricultural Statistics Service.

**All cows and heifers** that had calved totaled 1.59 million head, down 2% from last year.

**Beef cows** totaled 1.42 million head, down 2% from last year.

**Milk cows** totaled 168,000 head, down 3% from January 1, 2021.

**All heifers** 500 pounds and over totaled 2.14 million head, up 4% from last year.

**Steers** weighing 500 pounds and over totaled 2.04 million head, down 3% from last year.

**Bulls** weighing 500 pounds and over totaled 85,000 head, down 6% from last year.

**Calves** under 500 pounds totaled 645,000 head, down 5% from January 1, 2021.

**All cattle on feed** fed for slaughter in Kansas feedlots totaled 2.61 million head, down 2% from the previous year.

The **2021 calf crop** totaled 1.40 million head, down 6% from 2020.
