September Milk Production in California down 1.8 percent from last September

Milk production during September totaled 3.21 billion pounds, down 1.8 percent from September 2022 and down 2.8 percent August 2023. The number of milk cows on farms in California was 1.71 million head, down 9 thousand from September 2022 and unchanged from August 2023. Production per cow in California averaged 1,875 pounds, down 25 pounds from September 2022 and down 55 pounds from August 2023.


