SOUTH DAKOTA CROP PROGRESS AND CONDITION

SIoux FALLS, S.D. July 1, 2024 - For the week ending June 30, 2024, there were 4.1 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 1% very short, 5% short, 64% adequate, and 30% surplus. Subsoil moisture supplies rated 1% very short, 8% short, 66% adequate, and 25% surplus.

Field Crops Report: Corn condition rated 3% very poor, 6% poor, 18% fair, 55% good, and 18% excellent.

Soybean condition rated 4% very poor, 7% poor, 16% fair, 58% good, and 15% excellent. Soybeans emerged was 97%, near 99% last year and 95% for the five-year average. Blooming was 3%, behind 11% both last year and average.

Winter wheat condition rated 1% very poor, 4% poor, 19% fair, 57% good, and 19% excellent. Winter wheat headed was 96%, near 97% both last year and average.

Spring wheat condition rated 1% very poor, 2% poor, 16% fair, 74% good, and 7% excellent. Spring wheat headed was 66%, behind 84% last year, and near 67% average.

Oats condition rated 1% very poor, 1% poor, 14% fair, 72% good, and 12% excellent. Oats headed was 75%, behind 91% last year, and equal to average.

Sorghum condition rated 0% very poor, 0% poor, 16% fair, 74% good, and 10% excellent. Sorghum headed was 8%, behind 18% last year, but near 7% average.

Sunflower condition rated 1% very poor, 1% poor, 12% fair, 78% good, and 8% excellent. Sunflowers planted was 97%, near 99% last year, and equal to average. Emerged was 79%, ahead of 71% last year.

Pasture and Range Report: Pasture and range conditions rated 1% very poor, 4% poor, 23% fair, 49% good, and 23% excellent.
