Certified Organic Highlights

The 2016 Certified Organic Survey is a survey of all operations identified as having certified organic production. Certified organic farms must meet the standards set out by USDA’s Agricultural Marketing Service’s (AMS) National Organic Program (NOP) and be certified compliant by an approved agent of NOP. Results from the survey provide acreage, production, and sales data for a variety of certified organic crops and certified organic livestock.

In 2016, the United States had 14,217 certified organic farms that produced \$7.6 billion in certified organic products. Minnesota had 545 certified organic farms that produced \$106.5 million in certified organic products. Of the 130,688 acres of certified land in Minnesota, 112,023 acres were cropland and 18,665 acres were pastureland/rangeland. The top two certified commodities sold in Minnesota were milk from cows with sales valued at \$43.3 million and corn for grain or seed with sales valued at \$22.3 million.
